#### • Rules & Regulation

##### 01) Prevention of Sexual Harassment :-

As per the guidelines of Hon'ble Supreme Court of India college has established the cell for prevention of sexual harassment of women at work place, sexual Harassment of any type is prohibited in the college.

##### 02) Prohibition of Ragging :-

Ragging of any nature is totally prohibited in the college. If any student is found guilty of the offence of Ragging, he shall be punished as per the provisions of Maharashtra Prohibition of Ragging Act 1999.

##### 03) Compulsory Uniform :-

Uniform for boys is white pant & shirt, for girls is white salwar with kurta & white chunari or white pant & shirt.

##### 04) Student Council :-

Every year Student's Council is constituted as per the provisions of directives of Dr. B.A.M.U. Aurangabad. Student Council assists in organizing various programmes like debate competitions, Essay Competition, sports, etc.

##### 05) N.B. :-

Examination form will not be accepted unless all the fees are paid. Fees schedule is subject to variation from time to time.

##### 06) Attendance :-

In order to qualify for appearance at the University Examination, every student shall attend at least 75 percent of the lectures delivered in each subject.

##### 07) Refund of fees :-

Once the fees are paid, no request for refund will be entertained.

##### 08) Government Of India Scholarship :-

Eligible Scheduled Castes, Scheduled Tribes, VJNT, OBC, SBC, NT, Student get the Government of India Scholarship as per rules. Only the eligible students should submit G.O.I. application forms online & hardcopy to be submitted within a prescribed time-limit in the college.

#### • RULES OF DISCIPLINE

- 1) Enter or leave the lecture, hall with the permission of the teacher. As well as he should behave properly with his fellow students.
- 2) Students should take proper care of the college property. Any damages to furniture, fitting, gardens, window glasses, walls etc. will be treated as breach of discipline and will be liable to punishment/fine.
- 3) Student should take proper care of college Library books and journals.
- 4) Students should not be found loitering during college hours. They should get their official work done by standing in a queue at the respective windows of the office.
- 5) Students should be properly and neatly dressed in prescribed manner within the college premises.
- 6) Student must always carry their Identity cards and present for inspection as and when required.
- 7) Students must attend their classes regularly. They must attend at least 75% of lectures of all the concerned subject.
- 8) No students will commit any wrong inside or outside the college that will in anyway interfere with orderly administration and discipline of the college.
- 9) No students will be allowed to take part in politics or organize the meeting, processions or any movement without the prior permission of the Principal.
- 10) Any guest for any programs and the topics for any debate, etc. will be decided with the due consultation and permission of the Principal.
- 11) No student shall communicate any information about any matter concerning the college to the press.
- 12) No excursion trip shall be organized by any student without due permission of the Principal. Such trips will be accompanied by the teachers only. All the expenditure on such trips and other, incidental charges will be borne by the students concerned.
- 13) Student's council will be constituted as per rules and regulations and all the programmes and celebration will be held as per our college traditions.
- 14) The students not attending the lectures regularly, not submitting practicals in time and not appearing for college test will be fined.
- 15) The students are required to attend their classes in the prescribed uniform i.e. **white shirt & black pant for boys and white shirt salwar with Black Odhni or White saree with black blouse for girls.**
- 16) Entering the college campus after consumption of intoxicating material or consuming the same in the college campus is strictly prohibited.
- 17) Smoking, Chewing tobacco & spitting in college premises is strictly prohibited.
- 18) Ragging is strictly prohibited by Law.
- 19) If any student found indiscipline by disobeying the above rules of discipline, then strict action will be taken against her/him. Principal reserves the right to refuse or cancel the admission of any student if he feels that any students may cause or has caused the breach of the rules of discipline in letter and spirit.

#### • Eligibility for Admission

- 01) The bar council of India prescribed minimum qualification for admission to 03 years and 05 years law courses according to circular bearing No. (CIR) No. 3/1977 Dt. 19 sept. 1997.
- 02) Student seeking admission must have secured 45 % marks at the qualifying examination.
- 03) Application must be completed in all respect. Incomplete application shall not be accepted.
- 04) Application must be submitted along with all relevant documents.
- 05) To Confirm admission applicant shall deposit requisite amount towards part payment of the fees within 7 days after grant of admission test, the claim of the concerned applicant shall be lapsed. .

#### • Admission Process

- 01) For seeking admission to LL.B.-1(3 Years Law Course) & Pre-Law-1(5 years Law Course) according to BCI Circular bearing No. Le(CI) No.3/1997 Dt.19 th Sept. 1997 and Maharashtra Unaided Private Professional Educational (Regulation of Admission and Fees) Act, 2015 and Rules directed by Dr.Babasaheb Ambedkar Marathwada University, Aurangabad.
- 02) Minimum eligibility criteria for 3 years law course for open category 45 % and for S.C. & S.T. 40% of qualifying exam of any graduation.
- 03) For 5 Years law course minimum eligible criteria for open category 45% & for 40% of S.H.C. or equivalent qualification recognized by government of Maharashtra.
- 04) For Seeking admission to pre Law-1 (5 years Degree law course) & LL.B. I (3 years Degree law Course) shall be made in accordance with the notification of Higher & Technical Education Govt. of Maharashtra d 2nd April 2016.
- 05) Admission shall be made inter se merit and score of CET examination to conducted by government of Maharashtra for law admission
- 06) For admission students shall apply application for admission with all relevant documents as mentioned in application form submitted to college office during office hours in their own hand writing.
- 07) Application must be completed in all respect incomplete application shall not be accepted
- 08) After verification merit list will be displayed on the notice board.
